Ambulance Vehicle (AMBU)

A vehicle other than a government owned vehicle, specially constructed and solely used for carrying sick or injured persons. Concession does not entitle an operator to fit flashing lights and sirens. Only vehicles used solely by the Ambulance Service of NSW as defined under the *Health Services Act 1997* or a vehicle delegated by the Ambulance Service of NSW under their delegated authority may be fitted with flashing lights and sirens.

Civil Defence Vehicle (CIVL) / State Emergency Service (SES)

Vehicle used by a civil defence group, an industrial mutual aid group or a rescue organisation solely in connection with civil defence or rescue work arising from some general emergency or catastrophe such as drought, flood, fire or similar emergency. Vehicles must be registered in the name of the organisation controlling the work. Vehicles registered to government agencies, other than councils are not eligible.

Fire Fighting Vehicle (not Fire and Rescue NSW) (FIRE)

- Council-owned vehicles - used for bush fire control, and may also be used for road maintenance repair and construction, but not for any other purpose.
- Company-owned vehicle - used solely for and in connection with the control of bush fires.

Transport for people with a disability (HAND)

Passenger vehicle used solely for the work of conveying sick or injured (including intellectually or mobility impaired) people. Vehicles registered to government agencies are not eligible.

Mobile Crane (MCRA)

Mobile crane not let for hire.

Mine Rescue Vehicle (MINE)

Vehicle used solely for mine rescue work in accordance with the *Coal Industry Act 2001*.

Primary Producer Vehicle (PPG)

Vehicle used by a primary producer as defined under the *Motor Vehicles Taxation Act 1988*, or rural co-operative but not used or let for hire, and solely or principally for

- Carting primary products.
- Carting leaves which another primary producer has gathered and from which eucalyptus or other oil is to be distilled.
- Carting goods of any kind for use in a primary producers business or household.
- Purposes connected with the clearing of land to be used for primary production.

I possess one of the following forms of evidence of eligibility for this concession and will provide it to Roads and Maritime Services if required:

- A Tax Averaging or Assessment Certificate (not more than two years old),
- A declaration stating that you are a primary producer as defined by the *Motor Vehicles Taxation Act 1988*, signed by your tax agent or accountant (not more than 12 months old), or
- An energy grants credits scheme claim assessment (not more than two years old), provided the activity printed under Claims Details is shown as Agriculture, Forestry or Fishing.
- A Certificate of Incorporation from the Office of Fair Trading (for rural co-operatives).

Note: Under the *Motor Vehicles Taxation Act 1988*, fish farmers and plantation forest cultivators are primary producers. Commercial fishers and loggers are not primary producers under this legislation and are therefore not entitled to a primary producer registration concession.

Rural Lands Protection Board Vehicle (PAST)
Trucks and trailers used solely for the functions of Local Land Services.

Police Youth Club Vehicle (POLC)
Vehicle owned by a Police Youth Club and used solely for Police Youth purposes.

Roadwork by a Council, Park or Cemetery Trust (RDWK)
Vehicle owned by a Council, Park or Cemetery Trust and used solely for or in accordance with the:

- construction, maintenance or repair of roads, bridges or cemeteries including supervising such work; or
- removal of garbage or night soil; or
- rolling or maintenance of tennis courts, cricket pitches, lawns or pathways; or
- improving the surface of the ground or similar work and is not let for hire.

Roadwork General (RDWK)
Vehicle used solely for:

- the construction, maintenance or repair of roads or bridges; or
- removal of garbage or night soil; and is
- a self-propelled plant;
- a roadwork plant trailer; or
- a trailer used to carry roadwork plant.

School Student Driver Education Vehicle (SCHL)
Vehicle used solely or principally by a Government school or a registered non-Government school for the purpose of driver education of students.

Surf Life Saving Club Vehicle (SURF)
Vehicle used on road or road related areas solely to transport surf rescue boats.

Tow Trucks with 'Crane and Hook' Body (TOW)
Vehicle constructed to Partially lift and tow other vehicles, but not carry other vehicles, and the vehicle will be garaged in: *(please tick the appropriate Transport District)*

- Other Transport District

Federal Interstate Vehicle (FIRS, FIBS, FIPP)
Vehicle used to carry goods, produce or passengers to or from another State or Territory, in accordance with the *Interstate Road Transport Act 1985*.

Wheelchair Modified Vehicle (PRIV, with vehicle condition code V88)
Vehicle used substantially for private purposes and modified to allow wheelchair access and to transport them safely and securely (eg hoists, anchor points, additional doors etc). A compliance certificate issued by a licenced certifier on Roads and Maritime's' Vehicle Safety Compliance Certification Scheme is also required.

4. Customer / Organisation Declaration

I understand that my personal information is being collected and held for registration purposes by the Roads and Maritime Services 101 Miller Street, North Sydney NSW 2060.

Roads and Maritime is collecting your personal information in relation to your application for a vehicle registration concession and may retain and use it for driver licensing, motor vehicle, road transport and safety purposes. You are required to provide your personal information under road transport legislation and the *Motor Vehicles Taxation Act 1988*. We may refuse your application if you do not provide it. We may disclose your personal information to other driver licensing and vehicle registration agencies, to assess your application or verify the information you provide, for inquiries about motor accidents, to confirm compulsory third party (bodily injury) insurance is current, to anyone proposing to acquire an interest in your vehicle and in respect of inquiries relating to stolen or abandoned vehicles. Otherwise we will not disclose your personal information without your consent unless authorised by law. Roads and Maritime is subject to the *Privacy and Personal Information Protection Act 1998* and the *Health Records and Information Privacy Act 2002*. Your personal information will be held with us at 101 Miller Street, North Sydney NSW 2060. You have the right to access and correct the information if you believe that it is incorrect. You declare that:

- You are eligible for the concession.
- You will notify us within 14 days if your concession eligibility ceases.
- You understand that we have the right to require that you provide evidence that you are eligible for the concession and that failure to provide the required evidence may result in vehicle tax or registration charge being payable by you; or the registration being suspended or cancelled

Under road transport legislation, it is an offence to attempt to register or renew the registration of a vehicle by false statement or any misrepresentation or other dishonest means
